1. Name and address of the Association shall be : Social Integrated and development Society, Thattannagari Palli, Thimmampalli Mandal and post, Bagepalli taluk, Kolbar district.
2. Aims and objectives of the society : The aims and objectives of the society shall be as stated in the memorandum of the association.

3. THE CALENDER YEAR :-

The calender year of the Association shall be from 1st Jan. to 31st Dec. of every year. And the working hours of the association shall be 10-00 A.M. TO 5P.M. on the working days.

4. (a) MEMBERSHIP

The Membership of the society shall be open to all, any person who has attained the age of 19 years and introduced by any of the member of the governing body of the society such members shall pay Rs 250/P.A as Membership Fee, to become an ordinary members. Those who pay Rs. 500/P.A shall be the LIFE MEMBERS of the Society.

(b) The society shall maintain the membership Register containing all particulars of the membership.

(c) The member of the society will be deemed to continue as a member unless he/she tenders his/her resignation to the Member ship.

5. GOVERNING BODY:

There shall be 9 members in the Governing body, consisting of president, Secretary, Treasurer and 6 members. Whose duration will be one year.

PROCEEDINGS OF THE GOVERNING BODY

- a) The Governing body of the society shall meet atleast once in a month.
- b) Every meeting of the Governing body shall be presided over by the president.
- c) QUORUM:  
The quorum for the Governing body shall be 2/3rd of the entire Governing body, Any fraction in the 2/3rd shall be rounded of as one.
- d) There shall be clear seven (7) days notice of evry meeting to the members.
- e) Each member of the Governing body including the president shall have one vote and if their shall by any equality of votes on any question of the presiding officer shall be in addition have casting vote.
- f) Any business except as the Governing body may be general or special order Direct to be placed before the meeting, may be carried out be circulation amongst all its members and any resolution. So circulated and approved by a majority of the members of signing shall be as effecutal and bñinding, as it such a resolution has been passed at a meeting of the Governing body provided, that atleast 2/3rd of the members have rendered their views on the resolution.

7. FUNCTIONS AND POWERS OF THE GOVERNING BODY

- a) The Governing body shall carryout the aims and objects of the society as set forth in the Memorandum of Association.
- b) The subject of supervision and control of the society, the Governing body shall manage the affairs and funds of the society.
- c) The Governing body shall prepare the annual budget for the consideration by the General body.

ANNUAL REPORT:

A draft of the annual report and yearly accounts of the society shall be prepared by the Governing body be placed before the society in its annual general body meeting for consideration and approval.

GENERAL BODY

1. The General body meeting shall be held within 30 days of the Calender year, the meeting required 15 days prior notice quorum shall be 3/4th of the members and resolution passed in the meeting.

3. The functions of the General body meeting shall include the adopting the annual report of the society along with the accounts and balance sheet for the past year, to consider the Budget Estimate prepared by the Governing body and also items indicated in the Agenda.
